

Sr. No	Particulars / Action Point	Action Taken
1.	A full-fledged fact-checking module would be necessary to be taught, since it is a very up-and-coming domain of journalism	A fact-checking module was immediately introduced in the 'news reporting and editing' course from 2018 onwards. The students eventually also secured internships with fact-checking organizations and published more than 50 bylines.
2.	The students could be taught how to produce multimedia stories	It is usually covered as smaller assignments taken up into Project II and III.
3.	Inclusion of basics of investigative journalism.	A flexi-credit course on environmental and investigative journalism was introduced in 2019-21 programme structure. Also, the 2019 Corporate Interface event of journalism featured a day-long deliberation on investigative journalism with prominent investigative journalists as well as RTI activists.
